Sub: e-RD- Submission of Letter of Credit(LC) in case of goods traffic pertaining to Bangladesh
Ref: (i) Addendum No.3 to Rates Master Circular/e-RD/2019/0
(ii)Board's letter of even number dt.29.03.2022

Please refer to Addendum under reference(i) regarding guidelines for uploading Letter of Credit(LC) details in case of goods traffic pertaining to Bangladesh, effective from 1st April 2022.


As per extant guidelines, all customers(e-RD as well as who had placed physical indents) shall have to upload LC details in the system by 31st March 2022, else all indents should be treated as null and void and WRF, if any, will be refunded.

The matter has been reviewed and it has been decided to extend the afore-mentioned date of 31st March 2022, for uploading LC details till 30th April, 2022.

Now, customers who have placed indents, through e-RD or physically, till 31.03.2022 may upload LC details latest by 30.04.2022, else such indents should be treated as null and void and WRF, if any, will be refunded.

However, w.e.f. 01.04.2022, all new indents should be placed only through e-RD after submitting LC details as per the guidelines under reference(i).
