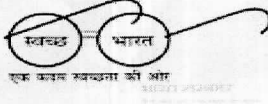


With reference to above, it is to inform that Balaghat (BTC) and Nainpur (NIR) railway station of NGP Division are opened for parcel traffic for six month on temporary basis, which is required to continue.

Balaghat (BTC) and Nainpur (NIR) station are newly opened section and with increasing of coaching trains in this section, it is expected that parcel traffic of Balaghat and Nainpur will increase in future, hence it is required to continue the opening of Balaghat and Nainpur for parcel traffic.

It is necessary to mention that Nainpur (NIR) station is identified for implementation of PMS under phase III.
