

**Sub: e-RD- Submission of Letter of Credit(LC) in case of goods traffic
pertaining to Bangladesh**

Ref: (i) Addendum No.03 to Rates Master Circular/e-RD/2019/0
(ii) Board's letter of even number dated 31.03.2022

A reference has been received from a freight customer highlighting the issue with regard to uploading of LC due to the difference in 'tonnage mentioned in LC' and 'minimum demand capacity' as per the system.

The matter has been examined and it is to clarify that customer may be allowed to upload LC, tonnage of which should be 'more or upto the weight of commodity' as declared by the customer while placing demand for wagons in e-RD. However, charging of freight should continue to be on the basis of PCC of wagons, as per extant guidelines.
