

Ref: Rates Master Circular on Block Rakes/Mini Rake/Two Point Combinations etc./2020 and Corrigenda thereto; & Board's message from DTT/POL to PCOM/NFR bearing No.12/20/001 POL dated 20.12.2018.

1. Reference Board's message above, notifying two point rake for POL traffic. Sanction of the Competent Authority is hereby accorded to regularize and permit, subject to conditions laid down in Para 7.0 of the Rates Master Circular dated 02.07.2020 on Block Rakes/Mini Rake/Two Point Combinations etc./2020, two point rake for POL traffic (tank wagons) as under:
  - (a) Lumding (IOPB) + Dimapur (IOSD) Ex.Bongaigaon (BRPN)
  - (b) Lumding (IOPB) + Dimapur (IOSD) Ex.Digboi (IOGS)
2. Annexure VI of above referred Rates Master Circular shall be modified accordingly.
3. All other terms and conditions prescribed in the above referred Rates Master Circular and Corrigenda thereto shall remain unchanged.
4. This shall come into force with effect from 20.05.2022 and shall remain in force till further advice.
5. This issues in consultation with Traffic Transportation Directorates and with the concurrence of Finance Directorate of Ministry of Railways.


