
1. Provisional 2nd replacement panel of Technician-III/Fitter/C&W of 01 (OBC/01) candidate, Cat. No. 09 in Level-2; 7th CPC against General Departmental Competitive Examination (GDCE) on South East Central Railway is hereby declared. This panel is purely provisional and does not give any right to any candidate for job in above notified post. If any malpractice is detected at any stage, their candidature will be terminated and the individual will be liable for criminal prosecution.
2. The Computer Based Test (CBT) for the above post conducted on 07.09.2019. The Document Verification was conducted between 24.02.2020 to 05.03.2020 at Railway Recruitment Cell, RTS Colony, Bilaspur.
3. Due care has been taken in while preparing the panel, RRC/SECR reserves the right to make any amendments to the provisionally declared panel at any subsequent stage. If any discrepancies or malpractices are noticed or brought to the notice of RRC, then RRC/SECR reserves the right to declare any candidate(s) unsuccessful or delete the name of any candidate (s) from the notified panel at any stage. The decision of Chairman/RRC/ SECR in the matter shall be final.
4. The panel is based on candidate's merit position, choice and medical fitness for the post.
5. Candidate working in above the pay level-2 will have to be reverted for joining the post of Technician-III; Level-2 (7th CPC).
6. The offer of appointment shall be sent separately by respective Units/Divisions. Hence for their posting and appointment letter candidates need not contact RRC.
7. The panel is purely provisional and appointments of candidates as Technician-III/Fitter/C&W post will completely depend on fulfilling all other conditions like passing

of requisite training, not undergoing any effective penalty, no SPE/Vig./DAR case is ongoing/pending/contemplated against them, fulfillment of other pre-recruitment formalities, verification of all relevant documents including caste certificate etc. appearance of one's Roll No. in the part panel does not confer any right for selection of any candidate, if found not satisfying above mentioned conditions (not restrictive).

8. The panel is purely provisional subject to outcome of OA Nos. 203/527/2020, 845/2021, 848/2021 and 868/2021 pending before Hon'ble CAT/Jabalpur.
