Sub: Haulage Charges for postal traffic for 2021-22 and 2022-23

Ref: 1. Railway Board's Freight Marketing Circulars No. 09 of 2021 dated 28.05.2021

2. DDG/Mail Operations letter no. 3-1/2021-D dated 06/09.05.2022

Haulage charges for Postal traffic carried in Postal Vans and Non-Postal Vans for the year 2020-21 were revised vide ref-i above.

- 2. As agreed by Department of Posts (vide letter under ref-ii) and approved by Ministry of Railways, Haulage Charges from the year 2021-22 onwards are to be revised as per the existing methodology on the basis of change in WPI-with 100% increase/decrease in WPI to be borne by Department of Posts.
- 3. Accordingly, It has now been decided to revise the Haulage charges for Postal Traffic carried in Postal Vans and Non-Postal Vans for the year 2021-22 and 2022-23 as per the aforementioned methodology, as under:

Distance Slabs (in km)	Haulage charges for the Postal Traffic ( in ₹ per Berth per KM)	
	2021-22	2022-23
0 – 500 km	₹1.01	₹1.02
501 – 1,000 km	₹0.64 subject to minimum realization of Haulage Charges applicable for 500 Km (Subject to minimum of ₹505)	₹0.65 subject to minimum realization of Haulage Charges applicable for 500 Km (Subject to minimum of ₹510)
1,001 km & above	₹0.53 subject to minimum realization of Haulage Charges applicable for 1,000 Km (Subject to minimum ₹640)	₹0.54 subject to minimum realization of Haulage Charges applicable for 1,000 Km (Subject to minimum of ₹650)



- 4. Point to point charges shall be rounded off to the next multiple of five.
- 5. Other terms and conditions mentioned in the letter dated 19.2.2007 and revised from time to time for charging of postal traffic, billing and payment will remain unchanged.
