Sub: Levy of terminal charge on automobile traffic.

Ref: Rates Circular Number 14 of 2019 dated 14.06.2019; and corrigenda thereto.

Reference above, Para 3 of Rates Circular No.14 of 2019 stipulated exemption from levy of terminal charge on automobile traffic and review of the same after one year from the date of issue of the circular i.e. 14.06.2019. It was also mentioned that the validity of the circular will be till further advice in terms of Rates Circular No.24 of 2018.

The matter of applicability of Terminal charge on automobile traffic was reviewed and the exemption notified vide Para 3 of Rates Circular No.14 of 2019 was considered to be continued up to 14.06.2021 in terms of Board's letter of even number dated 06.10.2020; up to 14.06.2022 in terms of corrigendum dated 23.06.2021 to Rates Circular Number 14 of 2019; and up to 31.12.2022 in terms of corrigendum dated 17.06.2022 to Rates Circular Number 14 of 2019.

Matter has been further reviewed and it has been decided to continue the validity of the exemption beyond 31.12.2022 for a further period of 1 year i.e. upto 31.12.2023.

This issues with the concurrence of the Finance Directorate of Ministry of Railways.
