The matter has been reviewed and it has been decided to extend the validity of aforementioned free time beyond 31.12.2022 for a further period of six months **i.e. upto 30.06.2023**. These guidelines will also be applicable in case of loading/unloading of Iron Ore in BOBYN wagons when supplied in place of open wagons.

The details regarding supply of BOBYN rake against an indent of open rake must be captured in the system. If a customer places an indent for BOXN rake and if BOBYN rake is supplied against such demand, then rail user(CGS) will change the stock type from BOXN to BOBYN in demand and free time as per the circular will be applicable. The system will capture such changes and generate MIS position for the same.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Railway Board.
