1. A proposal for movement of newly manufactured BOMN wagon was under consideration of Board.

2. The matter has been examined, and it has been decided by the Competent Authority that for the purpose of charging "BOMN" wagons, Permissible Carrying Capacity (PCC) and Loading Tolerance (*refer Rates Master Circular/PCC/CC+8 etc./2020/0*) shall be as under:

Wagon	PCC all Routes	Loading Tolerance
BOMN	35.85 tonnes	1 ton

2.1 The Standard Rake Size, Minimum number of wagons to be loaded (*refer Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc./2020/0*) shall be as under:


Wagon	Standard Rake Size	Minimum number of wagons to be loaded
BOMN	32 wagons	31 wagons


2.2 The Designed Tare Weight of BOMN wagon (*refer Rates Master Circular/Weighment/2019/0*) shall be as under:

Wagon	Designed Tare Weight
BOMN	29.77 Tonnes

3. All other instructions of Rates Master Circular referred above shall remain the same.

4. These instructions shall come into force with effect from 09.01.2023 and shall remain in operation till further advice.


