NOTIFICATION NO.05/2023

Sub: Formation of panel for filling up the post of Loco Pilot Mail (M/L) PB-2, Pay Matrix Level-6 VIIth PC" additional allowance 2250/- Per month in Electrical (OP) department of Bilaspur Division/ SECR.

It is proposed to form a panel for filling up of 07 (Seven) post of LPM(ML) in Pay Matrix Level-6 in Electrical (OP) department of Bilaspur/SECR. The break-up of vacancies is as under:

Willingness from the eligible staff are hereby invited within 15 days i.e on or before 28.02.2023.

1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF :

Staff who have put in a minimum of two years service as LPP (M/L) are eligible for promotion as LPM (M/L) as per Seniority.
(Authority : Para 5.1 of PCPO/BSP's Estt Rule No.302/2019)

2. PROCEDURE FOR SUITABILITY:

- The category of LPM(M/L) is classified as Non – selection post, hence staff is to be called in 1:1 ratio. The vacancies are to be filled up by Seniority-Cum-Suitability.
- Suitability will be conducted on the basis of scrutiny of service records and grading of last three years APAR, D&A clearance.
- Staff are to be secured 06 marks out of 15 as aggregate in three years APAR.
(Authority : Para 3.1 of PCPO/BSP's Estt Rule No.302/2019, 200/2009 &196/2011)

3. PROVISION OF RESERVATION :

- The conditions set out by the Hon'ble Supreme Court has been complied as under:-
Quantifiable data has been collected in the cadre of LPM(M/L)(Elect./OP). Post based roster in the cadre of LPM(M/L)(Elect-OP) is also maintained in due compliance of the judgment of Hon'ble Supreme Court in the case R. K. Sabharwal Vs State of Punjab. It is seen that there is no shortfall of ST category hence, representation of STs in the cadre of LPM (M/L) (Elect./OP) is adequate. But, there is shortfall of 01 post in SC category. Hence, representation of SCs in the cadre of LPM (M/L) (Elect-OP) is inadequate.

- In accordance with Estt.Rule No. 54/19 and 168/22 this post not identified for reservation of PWBDs.

Keeping in view of the previous trend of receiving refusal of promotion from the empanelled staff , it has been decided to invite willingness from the following staff working as LPP(M/L) for promotion to the post of LPM(M/L) in pay matrix level-6 in Electrical (OP) department.

After receiving willingness from the above staff, suitability shall be adjudged on 1:1 basis in order of seniority. Hence above staff of LPP (M/L) may submit their willingness on or before 28.02.2023 positively otherwise it will be presumed that staff are unwilling for promotion. Thereafter a list of zone of consideration shall be prepared in order of seniority amongst willing candidates and suitability shall be finalized accordingly.

5. NOTIFYING TO THE STAFF:

The controlling officer/supervisor shall give wide publicity of notification to all eligible staff of Electrical (OP) department of Bilaspur Division and notification should be displayed at conspicuous place. It should be the responsibility of senior Subordinate/Supervisor to complete the formality in this respect.

6. LAST DATE FOR SUBMISSION OF REPRESENTATION/OBJECTION (IF ANY):

- a) Representation/Objections against eligibility list may be submitted to their respective Branch Officer on or before 25.02.2023 and branch officer will be forwarded all such representation to this office on or before 28.02.2023 in a consolidated manner along with covering letter to this office within 15 days (i.e. 28-02-2023) from the date of issue of this notification, failing which it shall be presumed that there is no representation against the eligibility list.
- b) Above staff of LPP(M/L) may submit their willingness on or before 28.02.2023 positively otherwise it will be presumed that staff unwilling for promotion. Thereafter a list of zone of consideration shall be prepared in order of seniority amongst willing candidates and suitability shall be finalized accordingly.
