Ref: Rates Circular Number 19 of 2020 and corrigenda thereto.

Reference above, Two Point/Multi Point loading & unloading rakes are allowed from time to time from Board's office. It has been decided by the Competent Authority that all such rakes shall be subject to levy of supplementary charge as per the extant guidelines.

Accordingly, Two Point/Multi Point destination allowed in terms of above referred Rates Circular and Corrigenda thereto shall be subject to levy of supplementary charge as per the extant guidelines, which is 5% for two point rake and 20% for multi point rake. All other details shall remain the same.

This shall come into force w.e.f. 17.02.2023 and shall remain valid as notified from time to time. As per the extant guidelines, 5% supplementary charge for Two point rakes is valid up to 30.06.2023 and 20% supplementary charge for Mult point rake is valid till further advice.
