Sub: Notification of PCC etc. of new high speed wagons

Ref: Rates Master Circular/PCC/CC+8 etc/2020/0 & corrigenda thereto; Rates Master Circular on Block Rakes/Mini Rake/Two Point Combination etc/2020/0 & corrigenda thereto; and Rates Master Circular/weighment/2019/0; & corrigenda/addenda thereto.

1. RDSO had undertaken a mission of increasing the speed of existing wagons. Accordingly speed of various wagons has been increased and these wagons have been assigned new transportation codes to distinguish them from the existing wagon types. These wagons are - BOXNM2, BOXNHSM2, BOXNRM2, BOXNLWM2, BOSTHSM2, BOSTHSM3, and BCNAHSM1.
2. Matter has been reviewed and the Competent Authority have decided that charging of these wagons shall be done as per their corresponding existing wagons which have already been notified in terms of the above referred Rates Master Circulars and corrigenda thereto. The modified wagons and their corresponding already notified wagons are as under:

SN	High speed new wagons	Equivalent existing wagons already notified
1	BOXNM2	BOXNM1
2	BOXNHSM2	BOXNHSM1
3	BOXNRM2	BOXNR
4	BOXNLWM2	BOXNLWM1
5	BOSTHSM2	BOST
6	BOSTHSM3	BOST
7	BCNAHSM1*	BCNAHS
	* notified separately vide corrigendum 74 to RMC/PCC../2020 dated 17.01.2023. To be treated as similar to BCN group of wagons.	

3. Modification to the above referred Rates Master Circulars shall be carried out accordingly.
4. For all the commercial/ charging purposes, these high speed wagons shall be treated as equivalent to already existing wagons as mentioned in the table above.
5. In case these wagons run with lower speed wagons as mixed rake, the rake should move at speed applicable to low speed wagons.
6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
