Sub: Formation of panel for filling up the post of Chief Controller-DPQ in PayMatrix Level-7 in Operating department of Bilaspur Division/SECR.

It is proposed to form a panel for filling up of 19 (Nineteen) post of Chief Controller in Pay Matrix Level-7 in Operating department of Bilaspur Division/SECR. The break-up of vacancies is as under:

1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF:

Staff who have put in a minimum of two years service as SCR (Optg.), Level-6 are eligible for promotion as Chief Controller, Level-7.

2. PROCEDURE FOR SUITABILITY:

- The category of Chief Controller is classified as Non – selection post, hence staff is to be called in 1:1 ratio. The vacancy is to be filled up by Seniority-Cum- Suitability.
- Suitability will be conducted on the basis of scrutiny of service records and grading of current years (03) APAR, D&A clearance.
- The candidates are to be secured 08 Marks out of 15 as aggregate in three years APAR.

3. PROVISION OF RESERVATION :

- The conditions set out by the Hon'ble Supreme Court has been complied as under:- Quantifiable data has been collected in the cadre of Chief Controller (Optg.) post based roster in the cadre of Chief Controller is also maintained in due compliance of the judgment of Hon'ble Supreme Court in the case R. K. Sabharwal Vs State of Punjab. Hence, representation of SC, STs in the cadre of Chief Controller is inadequate.
- The above suitability is provisional subject to final outcome of the OA No. 203/1153/2019 pending before Hon'ble CAT/JBP and SLP(C)No. 30621 of 2011 pending before Hon'ble Supreme Court in the matter of Jarnail Singh & others Vs Laxmi Narain Gupta & Others.

2. Rest 18(UR-14, SC-02, ST-02) post is Kept vacant due to available candidates are not completed 02 years residential period in feeder grade.



5. NOTIFYING TO THE STAFF:
