Reference is invited to this office Rates Circulars cited above, wherein, opening of Private siding of M/s SKS Power Generation (C.G.) Ltd. (Alpha Code-SKSS) served by SPGCL Block Cabin between ROB-BEF section of Bilaspur division was notified for inward traffic of Coal and outward traffic of Fly Ash and the validity period was extended time to time up to 28.02.2023.

Now, with the approval of competent authority (i.e. PCOM & PCCM), the validity period of above private siding (SKSS) is extended further upto 30.04.2023. Since the electrification work of this siding has now been completed, therefore, the freight shall now be charged on through distance basis. The distance will be reckoned as under:-

1.	Distance from CSB of ROB station to buffer end of SKSS siding	7.443 km
2.	Distance from CSB of BEF station to buffer end of SKSS siding	9.655km
