Sub : Congestion Surcharge on Goods Traffic Originating from Ports.

Ref.: Board's Rates Circular No. 13 of 2016; 13 of 2017; 3 of 2018; 4 of 2019; 5 of 2021; and 1 of 2022.

Vide Rates Circulars referred above, it was decided to withdraw the levy of Port Congestion Surcharge @ 10% on Base Freight Rate on all goods traffic, including Containers traffic, originating from Ports. These instructions are valid up to 31.03.2023.

The matter has been reviewed and the Competent Authority has decided that these instructions shall continue to be in force beyond 31.03.2023 till 31.03.2024.

This issues in consultation with Traffic Transportation and with the concurrence of Finance Directorate of Ministry of Railways.
