1. A new wagon "BFNSM1" has been commissioned and same is required to be put into operation. The Competent Authority has decided that this newly inducted wagon BFNSM1 shall be treated as equivalent to already notified BFNSM22.9 wagon.
2. Accordingly, BFNSM1 wagon shall bear the Commercial Specifications as under :


