1. Please refer to Board's Rates Circular under reference, wherein Charging of JCB was notified as Motor vehicles under Group No. 25(m) of the Goods Tariff No. 49 Part I, Vol.II., which was initially valid up to 05.04.2022 and was further extended up to 05.04.2023.


