1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF :

Staff who have put in a minimum of two years service as Tech-II are eligible for promotion as Tech-I, L-5 as per seniority.

2. PROCEDURE FOR SUITABILITY :

a. The category of Tech-I is classified as Non-selection post, accordingly staff are to be called in 1:1 ratio. The vacancy is to be filled up by seniority -Cum- Suitability.

b. Suitability will be conducted on the basis of scrutiny of service record and grading of current year APAR D &A clearance.

c. The candidates are to be secured 06 Marks out of 15 as aggregate in three year APAR.
