Sub: Formation of panel for filling up the post of Technician-I/TL (DPQ) in Pay Matrix Level-5 in Electrical (G) department of Bilaspur Division/ SECR.

It is proposed to form a panel for filling up of 11 (Eleven) post of Technician-I/TL in Pay Matrix Level-5 in Electrical (G) department of Bilaspur Division/SECR. The break-up of vacancies is as under:

1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF:

Staff who have put in a minimum of two years service as Technician-II/TL are eligible for promotion as Technician-I/TL.

2. PROCEDURE FOR SUITABILITY:

a. The category of Technician-I/TL is classified as Non – selection post, hence staff is to be Called in 1:1 ratio. The vacancy is to be filled up by Seniority-Cum-Suitability.

b. Suitability will be conducted on the basis of scrutiny of service records and grading of current 03 year APAR, D&A clearance.

c. The candidates are to be secured 06 Marks out of 15 as aggregate in three years APAR.

3. PROVISION OF RESERVATION:

a. The conditions set out by the Hon'ble Supreme Court has been complied as under:- Quantifiable data has been collected in the cadre of Technician-I/TL post based roster in the cadre of Technician-I/TL (DPQ.) is also maintained in due compliance of the judgment of Hon'ble Supreme Court in the case R. K. Sabharwal Vs State of Punjab. It is seen that there is shortfall of 04 vacancies of SC category hence, representation of SCs in the cadre of Technician-I/TL is inadequate.

b. Being Safety category, the post is not identified for reservation for PwBD.

Note - Out of 11 staff, Ten (10) staff have not completed 02 (two) years service in feeder grade. Hence 10 vacancies will remain unfilled in the instant suitability.
