- 1. Provisional part Panel of Goods Guard posts of **214** candidates, Cat. No. 03 in Level-5; 7<sup>th</sup> CPC against General Departmental Competitive Examination (GDCE) on South East Central Railway is hereby declared. This panel is purely provisional and does not give any right to any candidate for job in above notified post. If any malpractice is detected at any stage, their candidature will be terminated and the individual will be liable for criminal prosecution.
- 2. The Computer Based Test (CBT) for the above post was conducted on 02.01.2022 (2<sup>nd</sup> Shift). The Document Verification was conducted between 23.03.2022 to 01.04.2022 (08.04.2022, second chance for absentees) at Bilaspur.
- 3. Due care has been taken while preparing the panel; RRC/SECR reserves the right to make any amendments to the provisionally declared panel at any subsequent stage. If any discrepancies or malpractices are noticed or brought to the notice of RRC, then RRC/SECR reserves the right to declare any candidate(s) unsuccessful or delete the name of any candidate (s) from the notified panel at any stage. The decision of Chairman/RRC/SECR/BSP in the matter shall be final.
- 4. The panel is based on candidate's merit position, choice and medical fitness for the post.
- 5. The offer of appointment shall be sent separately by respective Units/Divisions. Hence for their posting and appointment letter, candidates need not contact RRC.
- 6. The panel is purely provisional and appointments of candidates as Goods Guard post will completely depend on fulfilling all other conditions like passing of requisite training, not undergoing any effective penalty, no SPE/Vig./DAR case is ongoing/pending/contemplated against them, fulfillment of other pre-recruitment formalities, verification of all relevant documents including caste certificate etc. Appearance of one's Roll No. in

the part panel does not confer any right for selection of any candidate, if found not satisfying above mentioned conditions.

- 7. SC/ST/OBC candidates who have yet not submitted caste certificate in prescribed Central Government format (Same as uploaded at the time of GDCE-01/2021 notification) with proper issuing authority are advised to submit the same when called for appointment.
- 8. Candidates who have not submitted the degree certificate at the time of document and candidature verification or have submitted the provisional degree certificate should submit the permanent degree certificate issued by the University at time of joining.
- 9. If the date of regularization of the candidate is after the closing date of GDCE Emp. No. 01/2021, then he/she can be de-panel at any stage of recruitment.
