Re-engagement of retired Railway staff

Sub: Proposal for re-engagement of retired Railway staff on monthly remuneration basis in exigency of services of Gati Shakti Units (GSUs) in Nagpur Division of S.E.C. Railway.

Ref:- 1. Railway Board's letter No. 2021/W-1/Genl./Gati Shakti Dtd.- 27-07-2022.
2. PCPO/SECR's letter No. P-HQ/GSU/1721 Dtd. 26.09.2022.

In terms of Railway Board's letter No. 2021/W-1/Genl./Gati Shakti dated 27-07-2022, it has been decided to fill up the following posts in Gati Shakti Unit in Nagpur Division of S.E.C. Railway by re-engagement of retired staff.

Accordingly, applications in prescribed format are invited from retired Railway Staff, who fulfil the following eligibility conditions, for the following posts as indicated below on monthly remuneration basis for the Gati Shakti Unit of Nagpur Division of S.E.C. Railway.

The following terms and conditions may kindly be noted


1. The willing applicants should visit SECR's web site www.secr.indianrailways.gov.in and download the application format from the path (Recruitment/News/Press Release> Recruitment > Nagpur > Notification of re-engagement of retired Railway staff in Nagpur Division). Applicants may apply in the prescribed format (Annexure-1) and send the scanned (PDF) copy along with required following document on or before **04.05.2023 upto 18.00 hrs.** In official email ID rectngpsecr@gmail.com.

- (a) Service Certificate
- (b) Pensioner Identity Card
- (c) Pension Payment Order

2. Mode of selection : Interview at Sr. Divisional Personnel Officer/Nagpur's Office, DRM Complex, S.E.C.Railway, Nagpur. For interview, date and time will be informed by email/phone. Applicants are requested to give their correct e-mail ID and phone number in their application. Applicants are advised to check their e-mail as well as SECR website for further information.
3. The last date for submission of the application is **04.05.2023 upto 18.00 hrs.** The applications received **after** this date shall not be accepted
4. Re-engagement shall be for a period of one year.
5. All the Railway Retired Supervisor, who have not attained 64 years 6 months as on closing date of notification (to ensure at least 06 months service is available after the re-engagement) shall be eligible for such re-engagement. No re-engaged employee shall be allowed to continue in service beyond 65 years of age.

6. Preference will be given to the Supervisors retired from the jurisdiction of Project areas.
7. The Administration will be liberty to terminate the services of the re-engaged employees even before completion of his/her term in case their work /conduct is found unsatisfactory by giving a Notice of 15 days. The re-engaged retired staff should give a notice of 15 days before discontinuing his/her service.
8. The employees Removed / Dismissed/ Compulsory retired as a result of DAR action or under Service Review (Rule-56j) are not eligible for re-engagement. Further employees retired under Safety Related Retirement Scheme (SRRS)/LARSGESS are also not eligible.
9. Monthly remuneration of retired Railway Supervisors being re-engaged will be determined as per Estt. Rule 307/19. The re-engaged employees are entitled only for monthly fixed remuneration i.e. reduction pension from his/her last pay drawn (i.e. Basic +DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.
10. The re-engagement employees may be permitted off on Sunday and National Holidays. However they may be called for duty on any day including Sundays and National Holidays for which Compensatory Rest may be given letter. In addition, Re-engaged staff may be granted two days leave for each completed month of engagement in Railway. The accumulated leave will lapse as soon as the contractual period is over and cannot be carried over to next contract (if any).
11. Duty pass may be provided for stretch of the journey involved on duty. They may be entitled to IInd Class "A" duty pass.
12. The re- engaged employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.
13. The retired re-engaged employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
14. Re-engagement shall be subject to prescribed medical fitness for the relevant category.
15. Suitability/competency of the applicant shall be adjudged by nominated Committee by the way of Interview before re-engagement.
16. The duty hours of the re-engaged employees would be 08 hours or as required. The duty can be changed as per the requirement of works by the administration with weekly off for one day.
17. While assigning the duties the safety and other operational requirement will be adequately considered.
18. The TA/DA shall be payable as per extant rules.
