

**NOTIFICATION NO. 38/2023**

**Sub:** Formation of panel for filling up the post of Chief Office Superintendent (Control Group)-DPQ in PayMatrix Level-7 in Operating department of Bilaspur Division/SECR.

It is proposed to form a panel for filling up of 01 (one) post of Chief Office Superintendent (Control group) in Pay Matrix Level-7 in Operating department of Bilaspur Division/SECR. The break-up of vacancies is as under:

**1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF:**

Staff who have put in a minimum of two years service as OS (Control group) of Optg., Level-6 are eligible for promotion as Chief Office Superintendent, Level-7.

**2. PROCEDURE FOR SUITABILITY:**

a. The category of Chief Office Superintendent is classified as Non – selection post, hence staff is to be called in 1:1 ratio. The vacancy is to be filled up by Seniority-Cum- Suitability.

b. Suitability will be conducted on the basis of scrutiny of service records and grading of last 03 years APAR's, D&A clearance.

c. The candidates are to be secured 08 Marks out of 15 as aggregate in last three years APAR's.

**3. PROVISION OF RESERVATION :**

a. The conditions set out by the Hon'ble Supreme Court has been complied as under:-Quantifiable data has been collected in the cadre of Chief Office Superintendent (Control group) L shape roster in the cadre of Chief Office Superintendent is also maintained in due compliance of the judgment of Hon'ble Supreme Court in the case R. K. Sabharwal Vs State of Punjab. It is seen that there is no shortfall of SC category hence, representation of SCs in the cadre of Ch. OS (Control group) is adequate.

b. The above suitability is provisional subject to final outcome of the contempt Petition (Civil) No. 30621 of 2011 dt. 26-09-2018 in the matter of Jarnail Singh & others Vs Lachhmi Narain Gupta & Others at Hon'ble Supreme Court.
