Railway Board vide Rates Circular No.17 of 2016 dated 20.05.2016 have issued guidelines for Merry-Go-Round (MGR) system. Further, MGR policy has been extended up to 30.04.2024 vide Rates Circular No.08 of 2023 dated 28.04.2023.

NTPC Limited, Lara has entered into 2<sup>nd</sup> agreement under MGR system for loading of coal from NTPC Coal Loading Siding at Talaipalli Mines **(Alpha Code: NTMK Numerical Code: 14122474)** Served by Kotarlia station to unloading terminal at track hopper of NTPC siding, Lara (NLSK) in the MGR circuit. The details of MGR system are as under:
