- 1. In terms of above referred Rates Circulars, the Operation of Merry-Go-Round (MGR) System by Railways is valid up to 30.04.2023.
- 2. The matter has been reviewed and the Competent Authority has decided to extend the validity of the system beyond 30.04.2023 for a further period of one year i.e. up to 30.04.2024.
- 3. It has also been decided that for the operation of the MGR system beyond 30.04.2023, the current rates shall be enhanced by 5% (five percent).
- 4. The Zonal Railways where the system is operative should monitor the same with a view to increase traffic.
- 5. All other terms and conditions stipulated in above referred Rates Circulars shall remain unchanged.
- 6. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
