
1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes are prescribed.
2. In terms of reference (i) above, General Manager is empowered to approve running of CC+8 routes operations. Other conditions and procedures remain same.
3. North Western Railway has forwarded a proposal with due approval of General Manager to include the **Udaipur City – Himmatnagar (UDZ)- (HMT) as CC+8 route.**
4. Since the route UDZ – HMT involves portion of Western Railway, it has been considered to notify the route in the list of already indentified CC+8 routes as under:

**Udaipur City – Himmatnagar (UDZ)- (HMT) over North Western Railway and Western Railway.**

5. Sanction of the Competent Authority is hereby accorded to include the above referred route of North Western Railway and Western Railway in the list of already identified CC+8 routes.
6. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
7. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.

8. These instructions shall come into effect from 28.05.2023 and shall remain valid till further advice.


