Sub: Notification for charging of freight on through distance basis up to buffer end/farthest point of exchange yard of M/s Hukumchand Jute Mill Siding served by Amlai.

At present, private siding of M/s Hukumchand Jute Mill siding (**Alpha Code MHJA**) served by Amlai is working on siding charge basis and distance is charged upto Amlai station and siding charge is levied for utilizing Railway engine for placement and drawn out of rake from Amlai and back.

Now, since customer is utilizing captive engine for placement/drawn out of rake from their exchange yard to the siding and back, therefore with the approval of competent authority (i.e. PCOM & PCCM), the private siding of M/s Hukumchand Jute Mill, served by Amlai is notified on through distance basis upto the exchange yard of the siding. The Distance will be reckoned as **Amlai + 3.900 Km.**

All other terms and conditions notified earlier will remain unchanged. Necessary data may be updated in the RBS & FOIS accordingly. This will be effective from **17.06.2023.**
