**Ref:** Railway Board's Rates Master Circular/PCC/CC+8/etc./2020/0 and Corrigenda thereto.

- 1. In terms of Corrigendum No.22 to RMC/PCC/2019/0 dated 26.02.2020, Permissible Carrying Capacity (PCC) and Loading Tolerance on various routes for "BOST" wagons, when used for carrying "Steel Pipes" (of different diameters), was notified w.e.f. 29.02.2020 till 31.03.2021. The same was allowed to be operative further w.e.f. 14.04.2021 till 30.06.2021 in terms of Corrigendum No.33 to RMC/PCC/2019/0 dated 14.04.2021; till 30.06.2022 in terms of Corrigendum No.41 to RMC/PCC/2019/0 dated 21.06.2021 and further till 30.06.2023 in terms of Corrigendum No.62 to RMC/PCC/2020/0 dated 30.06.2022.
- 2. The matter has been reviewed. The Competent Authority have now granted approval to charge the steel pipes traffic as per above guidelines beyond 30.06.2023 and shall remain in force till 31.12.2023.
- 3. All other terms and conditions of the Rates Master Circular under reference shall remain the same.
- 4. This is issued in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
