  - 1. Reference above, the conditions for various Transportation Products have been notified in terms of above referred circulars and are valid up to 30.06.2023.
  - 2. Reference viii above, Two/Multi points (loading as well as unloading) for automobile traffic is also allowed with levy of Supplementary charge @ 5% for Two points and 20% for Multi points.
  - 3. Matter has been reviewed and Competent Authority has granted approval to advice the followings:
    - i. Mini Rake shall continue to be charged as per the extant guidelines for a further period of one year i.e. 30.06.2024.
    - ii. Two/Multi point rake shall continue to be charged as per the extant guidelines for a further period of one year i.e. 30.06.2024.
    - iii. Two/Multi loading/unloading points for automobile traffic shall continue to be charged as per the extant guidelines for a further period of one year i.e. 30.06.2024.
  - iv. Congested Goods Sheds and levy of 5% congestion surcharge thereon shall continue to be out of the purview of Transportation Products till further advice.
  - v. The trainload benefit in BCNHL rake should incur in case loaded upto 42 wagons. That is minimum composition of BCNHL as defined in annexure-1 of RMC/2020 on Block Rakes/Mini rake/two point combination etc. will be revised from 57 to 42. The standard composition shall continue to be 58 wagons.

4. All other terms and conditions associated with the traffic shall remain the same.
