- 1. In terms of Annexure-I to Board's Rates Master Circular/PCC/CC+8 etc/2020/0 and corrigenda thereto, Permissible Carrying Capacity (PCC) and Loading Tolerance of various wagons have been notified.
- 2. The issue has been examined. It has been decided by the Competent Authority that the Permissible Carrying Capacity (PCC) of various BOXN type wagons when loaded with the commodity "RED MUD" on CC+8 routes shall be as under:
