In terms of Railway Board's Letter No. above, it has been decided to fill up the following posts in Gati Shakti Unit in Bilaspur Division of SECR by Re-engagement of retired staff.

Accordingly, applications in prescribed format are invited from retired railway staff, fulfill the following eligibility conditions for the following posts as indicated below on monthly remuneration basis for the Gati Shakti Unit of Bilaspur Division of SECR as follows :-

**Re-engagement of Retired Railway staff on Bilaspur Division and application should be submitted only through e-mail id: [srdpo.omr@gmail.com](mailto:srdpo.omr@gmail.com), Applications in physical and/or any other mode will not be entertained.**


1. The last date for submission of the application is **25-08-2023**. The applications received after this date shall not be accepted.
2. Re-engagement shall be for a period of one year.
3. All the Railway Retired Supervisor, who have not attained 64 years 6 months as on closing date of notification ( to ensure at least 06 months service is available after the re-engagement) shall be eligible for such re-engagement. No re-engaged employee shall be allowed to continue in service beyond 65 years of age.
4. Preference will be given to the Supervisors retired from the jurisdiction of Project areas.
5. The Administration will be liberty to terminate the services of the re-engaged employees even before completion of his/her term in case their work /conduct is found unsatisfactory by giving a Notice of 15 days. The re-engaged retired staff should give a notice of 15 days before discontinuing his/her service.
6. The Re-engagement may be discontinued when regular staff posted.

7. The employees Removed / Dismissed/ Compulsory retired as a result of DAR action or under Service Review (Rule-56j) are not eligible for re-engagement. Further employees retired under Safety Related Retirement Scheme (SRRS)/LARSGESS are also not eligible.
8. Monthly remuneration of retired Railway Supervisors being re-engaged will be determined as per Estt. Rule 307/19. The re-engaged employees are entitled only for monthly fixed remuneration i.e. reduction pension from his /her last pay drawn (i.e. Basic +DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay at the time of retirement.
9. The re-engagement employees may be permitted off on Sunday and National Holidays. However they may be called for duty on any day including Sundays and National Holidays for which Compensatory Rest may be given later. In addition, Re-engaged staff may be granted two days leave for each completed month of engagement in Railway. The accumulated leave will lapse as soon as the contractual period is over and cannot be carried over to next contract (if any).
10. Duty pass may be provided for stretch of the journey involved on duty. They may be entitled to 2<sup>nd</sup> Class "A" duty pass.
11. The re-engagement employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.
12. The retired re-engaged employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
13. Re-engagement shall be subject to prescribed medical fitness for the relevant category.
14. Suitability /competency of the applicant shall be adjudged by nominated Committee by the way of Interview before re-engagement.
15. The duty hours of the re-engaged employees would be 08 hours or as required. The duty can be changed as per the requirement of works by the administration with weekly off for one day.
16. Copy of any of the following documents should invariably be attached with the application.
  - (i) Service Certificate
  - (ii) Pensioner Identity Card
  - (iii) Pension Payment Order
17. While assigning the duties the safety and other operational requirement will be adequately considered.
18. The TA /DA shall be payable as per extant rules.
