1. Provisional part Panel of **115** candidates of various posts, in Level-1; 7th CPC Pay Matrix against Centralized Employment Notification No. CEN RRC-01/2019 on South East Central Railway is hereby declared. This part panel is purely provisional and does not give any right to any candidate for job in above notified post. If any malpractice is detected at any stage, their candidature will be terminated and the individual will be liable for criminal prosecution.
2. The Computer Based Test (CBT) for the above post was conducted during the period 17.08.2022 to 11.10.2022 by Railway Recruitment Boards (RRBs). The Document Verification was conducted between 06.02.2023 to 23.02.2023 (22.02.2023 to 24.02.2023, second chance for absentees) at Bilaspur, Raipur and Nagpur divisions. & 15.05.2023 to 17.05.2023 (18.05.2023, second chance for absentees) at Bilaspur division.
3. The part Panel is prepared on the basis of Final normalized marks/overall merit rank and on being declared fit in Medical categories for recruitment to the posts in Level-1 of 7th CPC Pay Matrix.
4. This is a provisional part panel and Roll Numbers of some candidates have not been declared due to Non-qualifying the Medical examination in requisite medical standards.
5. Due care has been taken while preparing the panel; RRC/SECR reserves the right to make any amendments to the provisionally declared panel at any subsequent stage. If any discrepancies or malpractices are noticed or brought to the notice of RRC, then RRC/SECR reserves the right to declare any candidate(s) unsuccessful or delete the name of any candidate (s) from the notified panel at any stage. The decision of Chairman/RRC/SECR/BSP in the matter shall be final.
6. The cases where the name of candidates appears differently in various certificates may be examined thoroughly. The original documents including Medical fitness certificate

may be verified before issue of Appointment Orders. The authenticity of testimonials in proof of educational qualification, Date of Birth, Caste certificates, EWS certificates submitted by candidates empanelled against reserved vacancies may be verified before issue of offer of Appointment.

7. The panel is based on candidate's merit position, choice, community, availability of Post and medical fitness.
8. The offer of appointment shall be sent separately by the respective Units/Divisions where the candidates are allotted. The offer of appointment should be issued after verification as per extant rules.
9. The panel is purely provisional and appointments of candidates in level-1 post will completely depend on fulfilling all other conditions like passing of requisite training, fulfillment of other pre-recruitment formalities, verification of all relevant documents including caste certificate etc. Appearance of one's Roll No. in the part panel does not confer any right for selection of any candidate.
10. SC/ST/OBC candidates who have yet not submitted caste certificate in prescribed Central Government format (Same as uploaded at the time of CEN RRC-01/2019 notification) with proper issuing authority are advised to submit the same when called for appointment, failing which their candidature will be cancelled and delete the name/roll number of candidate (s) from the notified panel.
11. Allotment of posts shall be subjected to the preference/merit position/fit in requisite Medical standard and vacancy position. Candidates should note that their post allotment is purely provisional; the administration can change it at any stage according to its need.
12. Those serving candidates in any Central/State Government Department (including those undergoing induction training/probation) including Railways or Public sector undertakings, who have not submitted No Objection Certificate (NOC) for serving employee, they should submit No Objection Certificate (NOC) at the time of appointment, failing which their candidature will be cancelled and delete the name/roll number of candidate (s) from the notified panel.
