Sub: Transportation and charging of 'Track Machine' owned by other than Indian Railways.

- 1.0 Sanction of the Competent Authority is hereby accorded to permit transportation and charging of Track Machines owned by entities other than Indian Railways under terms and conditions as per the following:
  - Transportation and charging of 'Track Machine' owned by other than Indian Railways will be for transporting the same from the siding of Track Machine Manufacturer/ Indian Railways to the required place and vice-versa or any other movement over Indian Railways. The transportation/ charging will be subject to the following terms and conditions:
    - i. Track Machine, which are Self-propelled and are required to be carried without attachment of engine, shall be charged @ ₹ 250 per Track Machine per km. subject to a minimum of ₹ 25,000/- per Track Machine.
    - ii. Track Machine, which are non-self-propelled, and are required to be carried with attachment of engine and shall be charged @ ₹ 480 per Track Machine per km. subject to a minimum of ₹ 48,000/- per Track Machine.
    - iii. Track Machines, which run as a trainset in haulage like RGM, TRT etc. shall be charged @ ₹3,720/- per km. subject to a minimum of ₹3,72,000/-.
  - 2. Track Machines, which are over-dimensional in nature, shall be subject to levy of Infringement Charges to the extant guidelines.
  - 3. Fitness of Track Machine to run over Indian Railways duly considering safety of Track etc. will be granted by Engineering Department of Zonal Railways.
  - 4. Escort, Crew Member etc., if any provided, shall be charged to the extant guidelines.
  - 5. Track Machine, if stabled over Indian Railways' land, shall be subject to levy of stabling charges etc. to the extant guidelines.
  - Appropriate last vehicle mark shall be attached at the rear end of such track machine.
- 2.0 There shall be no charge levied for movement of Tack Machines of Indian Railways.
- 3.0 This shall come into force w.e.f. 20.08.2023 and shall remain valid till 19.08.2024.

- 4.0 The track machine loading railways shall provide details of transportation of track machines and charges collected thereon.
- 5.0 This issues in consultation with Safety, Civil Engineering, Mechanical, Traffic Transportation, Track Directorates and with the concurrence of Finance Directorate of Ministry of Railways.
