- 1. In terms of Corrigendum No.02 to Rates Circular No.21 of 2020 dated 31.08.2022, the Hire Charges on Wagons interchanged were notified for the period from 01.09.2022 to 31.08.2023.
- 2. The matter has been reviewed and the Competent Authority has decided to revise the rates of the Hire Charges on Wagons interchanged beyond 31.08.2022 as under:

a. Hire charges for inter-railway financial adjustment:
