

3.0 Matter has been reviewed, in the light of South East Central Railway's proposal, the Competent Authority has approved to add following route in the list attached as Annexure-IV of Rates Master Circular under reference (iii) above, as 25 Tonne axle load notified route:

Dallirajhara(DRZ)- Antagarh(AAGH)

4.0 Accordingly Annexure-IV of Rates Master Circular under reference (iii) above shall be modified.

5.0 These instructions shall come into effect from 16.09.2023 and shall remain valid till further advice.


