Notification -No 108 /2023

Sub:-Formation of panel of filling up the post of Tech-III against (50% DPQ) in pay Matrix Level-2 in Electrical (TRS) department of Bilaspur Division/SECR

It is proposed to form a panel for filling up of 43 (Forty Three) vacancies (Including higher grade & anticipated) for promotion to the post of Tech-III in pay Matrix Level-2 in Electrical (TRS) department of Bilaspur Division/SECR. The break-up of vacancies is as under:-

Out of the 43 posts, 02 posts are reserved for PWBD as above .

N.B- Empanelment of candidates against these posts is purely provisional subject to extension of currency of the posts from time to time

1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF :

Staff who have put in a minimum of two years service as Assistant TRS are eligible for promotion as Tech-III, L-2 as per seniority.

2. PROCEDURE FOR SUITABILITY/TRADE TEST :

a.The category of Tech-III Level-2 against 50%DPQ is classified as Non-selection post, accordingly staff are to be called in 1:1 ratio. The vacancies are to be filled up by seniority –Cum- Suitability in the manner of conducting Trade Test.

b. Trade Test will be conducted in terms of SECR Estt. Srl No. 215/2019 and 66/2021.

3. PROVISION OF RESERVATION :

A.The candidate set out by the Hon'ble Supreme Court has been complied as under:- Quantifiable data has been collected in the cadre of Technician-III/TRS post based roster in the cadre of Technician-III/TRS(DPQ) is also maintained in due compliance of the judgment of Hon'ble Supreme Court in the case R.K.; Sabharwal Vs state of Punjab.. There is 04-SC shortfall candidates and 10 UR candidates due to non completion or nearly completion of 02 years service as Asst. ELS, hence the remaining post will be carry forward for future Trade test .
