Sub: Rates for Automobile Traffic carried in NMG/NMGH/NMGHS and BCCNR wagons.

Ref: Board's Rates Circular no.32 of 2021 dated 30.11.2021 and its corrigenda.

1. In terms of Rates Circular no.32 of 2021 dated 30.11.2021, the freight rates for Automobile Traffic, when moved in NMG, BCCNR and BCACM wagons were revised and notified for the period from 01.12.2021 to 31.05.2022. The same were extended and now valid up to 30.11.2023 in terms of its Corrigendum No.03.
2. Now the Competent Authority has reviewed and decided to revise the present rates for Automobile traffic, when carried in NMG/NMGH/NMGHS and BCCNR, as per the Annexure attached.
3. Rates for BCACM wagons shall remain unchanged.
4. All other terms and conditions mentioned in above referred Rates Circular and its corrigenda shall remain the same.
5. This shall come into force w.e.f. 01.12.2023 and shall remain valid for further six months i.e. up to 31.05.2024.
6. This issues in consultation with Freight Marketing Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
