Reference is invited to this office Rates Circular cited above, wherein, Gati Shakti Multi-Model Cargo Terminal (GCT) named as **SECL Chhal Mines (SLCC)** served by Chhal station owned by South Eastern Coalfields Ltd. was opened on shunting charge basis as it was not electrified.

Now, the electrification work of this GCT has been completed, therefore, the freight shall now be charged on **through distance basis** (w.e.f 21.12.2023) by reckoning the distance as **CHHL + 9.630 Km.**

This GCT will work under the Engine on Load system (EOL).

This has the approval of competent authority. All other terms & conditions notified earlier for this GCT will remain unchanged.
