1. Please refer to Annexure III to Rates Master Circular under reference at (ii) above, wherein list of CC+8 routes are prescribed.

  5. Accordingly, Annexure-III of Rates Master Circular under reference (ii) above shall be modified.
  6. All other details of the Rates Master Circular & Corrigenda thereto under reference shall continue to apply unchanged.
  7. These instructions shall come into effect from 10.01.2024 and shall remain valid till further advice.
