- 9) Income Certificate for Waiving examination fee for Economically Backward Classes as per Annexure IIIA.
- 10) Minority Community declaration on Non-judicial Stamp paper as per Annexure IV of notification.
- 11) Self certificate by the Transgender candidate.
- 12) J & K domicile certificate wherever applicable.
- 13) Decree of divorce/Judicial separation from the Competent Court of law and affidavit stating that the candidate has not re-married, in case applicable.
- 14) In case of Widow, death certificate of spouse and affidavit stating that the candidate has not re-married.
- 15) Candidates must bring all original educational mark sheet & certificates, caste certificate and certificates mentioned in CEN RRC-01/2019 notification during document verification.
- 16) Candidates must bring original counter foil of CBT and PET (PET except PwBD candidates) call letters and ONLINE application form.
- 17) Candidates must bring two sets photo copy with self attested of all documents.
