Sub: Formation of panel for filling up the post of Ch.S&WI DPQ in Pay Matrix Level-7 in Personnel department of Bilaspur Division/SECR.

It is proposed to form a panel for filling up of **04** (Four) posts of Ch.S&WI in Pay Matrix Level-7 in Personnel department of Bilaspur Division/SECR. The break-up of vacancies is as under:

1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF:

Staff who have put in a minimum of two years service as S&WI are eligible for promotion as Ch.S&WI.

2. PROCEDURE FOR SUITABILITY:

- The category of Ch.S&WI is classified as Non – selection post, hence staff is to be called in **1:1** ratio. The vacancy is to be filled up by Seniority-Cum-Suitability.
- Suitability will be conducted on the basis of scrutiny of service records and grading of current 03 years APAR, D&A clearance.
- The candidates are to be secured 08 Marks out of 15 as aggregate in three years APAR.

3. PROVISION OF RESERVATION:

- The conditions set out by the Hon'ble Supreme Court has been complied as under:- Quantifiable data has been collected in the cadre of Ch. S&WI. L-shaped roster in the cadre of Ch.S&WI(DPQ.) is also maintained in due compliance of the judgment of Hon'ble Supreme Court in the case R. K. Sabharwal Vs State of Punjab. It is seen that there is shortfall of SC & ST category hence, representation of SC & ST in the cadre of Ch. S&WI is inadequate.
- The above suitability is provisional subject to final outcome of the contempt Petition (Civil) No. 30621/2014 dtd. 26-09-2018 in the matter of Jarnail Singh & others Vs Lachhmi Narain Gupta & other at Hon'ble Supreme Court.
