1. In terms of Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0, Permissible Carrying Capacity of various wagons have been notified up to one decimal place. The same has been reviewed and the Competent Authority has decided to revise as under:

1.1. SNo. 11 and 12 of CATEGORY "D. SPECIAL WAGONS" on Page 6 of the Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0 shall be read as under:

1.2. The above shall be effective from 23.05.2024 and shall remain in operation till further advice.

2. It has been further advised to refer Annexure-IA of Corrigendum No. 97 to RMC on PCC/CC+8 etc./2020/0 and the entry at S.No. 21 of Category "C. FLAT WAGONS" on Page 6, the word "FMPAB" shall be read as "FMPB".

3. All other terms and conditions of Rates Master Circular referred above and Corrigenda thereto shall remain the same.

4. This issues in consultation with Traffic Transportation, Mechanical Engineering Directorates and with the concurrence of Finance Directorate of the Ministry of Railways.


