Sub: Dynamic Pricing Policy – Levy of Busy Season Charge

Ref: Board's Rates Master Circular /Dynamic Pricing Policy/2015/0 dated 20.07.2015 and Corrigenda/Clarification thereto.

Policy guidelines were issued from time to time in terms of Board's letter under reference for levy of Busy Season Charge (BSC) on goods traffic.

2.0 The matter has been reviewed. In supersession to all earlier instructions on the subject, sanction of the Competent Authority is hereby accorded for levy of Busy Season Charge on goods traffic as per the following:

SNo.	Commodities	Rate of Busy Season Charge	Levied during period
1.	All commodities transported in stocks other than covered wagons*	15%	1 st April to 31 st March
2.	All commodities transported in covered wagons*	15%	1 st October to 31 st August
3.	Container Traffic	10%	1 st April to 31 st March
4.	Automobile Traffic moving in NMG group of wagons, BCACM, BCCNR & privately owned wagons for automobile like BCACBM wagons etc.	Nil	
5.	Coal & Coke		
6.	MGR traffic		

***Note:** Covered wagons refer to all wagons of BCX group, BCN group, BCNHL group, BCCW group, BCFC group and its equivalent wagons. It does not include Tank wagons.

3.0 Busy Season Charge will be levied on Base Freight Rates or Haulage Charges or Container Class rate, whichever is applicable.

4.0 Any exemption available to the above traffic regarding levy of Busy Season Charge in any circular/instructions stands modified to this extent.




