It is proposed to form a panel for filling up the post of SSE(Works) in Pay Matrix Level-7 against 80% DPQ in Engg Deptt department of BSP Division/SECR

1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF:

Staff who have put in a minimum of two years service as JE(Works) level-06 of ENGG Deptt. are eligible for promotion as SSE(Works) Level-07.

2. PROCEDURE FOR SUITABILITY:

- The category of SSE(Works), level-7 against 80% DPQ is classified as Non – selection post, hence staff is to be Called in 1:1 ratio. The vacancy is to be filled up by Seniority-Cum-Suitability basis.
- Suitability will be adjudged on the basis of scrutiny of service records and grading of current 03 years APAR, D&A clearance.
- The candidates are to be secured 08 Marks out of 15 as aggregate in three years APAR.

3. PROVISION OF RESERVATION:

K. Sabharwal Vs State of Punjab.
- The above suitability is provisional subject to final outcome of the contempt Petition (Civil) No. 30621/2014 dtd. 26-09-2018 in the matter of Jarnail Singh & others Vs Lachhmi Narain Gupta & other at Hon'ble Supreme Court.
