
Vide Freight Marketing Circular No. 14 of 2022 dated 11.07.2022 applicability of freight rates for utilization of NMG rakes for transportation of parcel traffic on an experimental basis for one year was issued. Further, the currency of this instruction was extended for a further period of one year i.e. upto 10.07.2024.

The matter has been reviewed and it has been decided to extend the currency of Freight Marketing Circular No. 14 of 2022 for another period of one year i.e. upto 10.07.2025 subject to following stipulation:

- 1) The variant of NMG may be used for parcel traffic only when the automobile traffic is not available.
- 2) Preferential moving parcel traffic in NMGHS and automobile in the other variants to promote volumetric throughput.

This issues in concurrence with the Finance Directorate of the Ministry of Railways.


