PREFACE

- This manual set forth the rules, regulations and procedures for dealing with Accidents and should be read in conjunction with the General and Subsidiary Rules and other instructions issued from time to time. Nothing in these rules shall be read as cancelling, amending or modifying any of the General or Subsidiary Rules or Rules of other Manuals of this Railway.
- 2. This Manual is prepared for the guidance of all staff of S.E.C.Railway who deal or may have to deal with Accidents.
- Railway servants dealing with accidents must possess a copy of this Manual and should be conversant with the portions concerned to their duties. They should also be conversant with the amendments made to this manual from time to time. The Addendum and Corrigendum should be entered serially in the space provided for this.
- 4. Extracts of various Acts of the Government of India have been given wherever necessary for reference only. However in case of any doubt or for detailed information, the original Act should be referred.
- 5. These rules apply throughout South East Central Railway to all its open lines, lines under construction and sidings whether Railway, Private or Assisted which are worked by this railway.
- 6. Though every care has been taken to print this book carefully, correction and omission if any may be brought to the notice of the undersigned.
