Item 09: Court Cases pertaining to SBE-III, if any (give details separately)

- 1. No. of cases: One WPC No. 3521/2021 filed before Hon'ble High Court, Bilaspur
- 2. Prayer: for directions to conduct the Secret Ballot Elections for recognition of the Trade Union in accordance with the 'Final Modalities, 2019' issued by the Railway Board in a time bound manner. The Union also filed Application for interim relief for directions to restrain the Railways in permitting SECRMC to take part in the meetings as a recognized union during the pendency of the present Writ Petition.
- Directions: Hon'ble High Court vide orders dated 21.03.2024 directed to notify the elections within a period of four months from the date of receipt of a copy of the order.
- Application for Extension of Time: Railways filed MCC No. 717/2024 before Hon'ble High Court, Bilaspur on 24.07.2024 seeking six months additional time for compliance of orders dated 21.03.2024 passed in WPC No. 3521/2021. The said MCC last listed on 13.08.2024 and further not listed.

5. <u>Compliance</u>: Hon'ble High Court, Bilaspur had been appraised of the Railway Board's letter No. 2024/SBEC-III/Elections dated 30.08.2024 fixing the polling dates on 4th, 5th & 6th December, 2024.
