On the basis of Computer Based Test (CBT) and Computer Based Aptitude Test (CBAT) for the post of Station Master, Category No. 02 which were held on 02.01.2022 (I<sup>st</sup> Shift) and 03.03.2022 respectively against General Departmental Competitive Examination (GDCE) the following candidates are provisionally found successful for document and candidature verification against replacement panel.

In case of two or more candidates securing same marks, their merit position shall be determined by age criteria i.e., older person shall be placed at higher merit and in case age being same, then alphabetical order (A to Z) of the name shall be taken into account to break the tie.

The result of the candidates is completely provisional. Candidates found successful in document and candidature verification will be sent for Medical Examination but panel will be finalised on the basis of merit, community, available vacancies and A-2 medical fitness.

OBC/NCL candidates have to submit latest OBC/NCL certificates in the prescribed Central Gov. format (same as uploaded at the time of GDCE-01/2021 notification) with non-creamy layer certification which is not more than one year old as on the date of document and candidature verification.

The document and candidature verification will be done at Railway Recruitment Cell, Near Kendriya Vidyalaya, RTS Colony, Bilaspur (C.G.), Pin- 495004 on **27.11.2024** at 09.30 am. If they are absent during document and candidature verification on 27.11.2024 they are advised to attend document and candidature verification on later date **28.11.2024** (Last Chance) at 09.30 am at the same venue and should produce documentary evidence that the candidate had appeared in a University/Govt. examination or due to his personal sickness. No other reason for absence in DV will be considered.

The medical test of the candidates will be held on the next day of document and candidature verification at any one railway hospital of Bilaspur/Raipur/Nagpur division. Candidates come with its preparation. Candidate should bring 4 latest clean passport size colour photographs without wearing sunglass/cap.

In document verification, candidates should bring original mark shit and certificates of all their educational qualifications, degree certificate, caste certificate (format as uploaded at the time of notification), counter foil of CBT and CBAT call letter, Pay Slip for the month of October 2024 etc. and also bring one set of self-attested photo copy of all documents.
