

It is informed that Railway Board has filed an SLP before the Hon'ble Supreme Court of India against the Order dated 14.11.2024 by the Hon'ble High Court of Bombay in W.P. No. 16478/2024, in the case of CRTU & AIRTU vs Union of India.

2. In view of the above, it is expected that the printing of Final Postal Ballot Paper is likely to be delayed. Therefore, the last date for display of printed Ballot Paper is extended to **26.11.2024(Tuesday)**. Accordingly, the last date for delivery/despatch of postal ballot by RO is extended upto **28.11.2024(Thursday)** for which RO/ARO/Postal Ballot Officer have to make special arrangements including deployment of personal messengers for delivery of Postal Ballot Papers. The last date for delivery of voted postal ballot shall remain as per Para 9 and 10 of Part 1 of Annexure VI of Final Modalities, that is as follows:-
