Railway Board vide letter under reference 1 has issued modalities regarding Postal Ballot system under Annexure-VI. Para 9, Part –I of the annexure prescribes following mode of submission of voted Postal Ballot Paper:-

1. By Speed Post,
2. Personally deliver to RO/ARO's Officer i.e by dropping the voted postal ballot paper in the Ballot Box kept for this purpose in the custody of Returning Officer.

Board vide letter dated 28.11.2024 u/ref-2, circulated vide this office letter u/ref-3, had further issued subsequent instructions in relaxation to earlier provisions on Postal Ballot System. As per instruction, one additional mode of submission of voted Postal Ballot Paper ie keeping the Ballot Box in POs office has been provided. Postal Ballot beneficiaries may drop their voted postal ballot in the ballot boxes so kept for these purposes in the Divisions /Units. A copy of the railway board letter is enclosed herewith for ready reference and further compliance please.

It is also mentioned that postal ballot paper to the eligible employees has been issued along with a envelop having RO address and stamped. Hence, It should be ensured that the voted postal ballot paper should be kept inside the envelope addressed to 'Returning Officer' and the same is dropped in the Ballot Box kept in the custody of Presiding officer for this purpose only. Ballot paper should not be dropped in Box without envelop. Also, the same should not to be dropped in any other polling booth.

Therefore, Postal Ballot beneficiaries may opt for any of the modes specified above for casting their vote. Wide publicity of the above instruction may please be ensured.

Sub: Postal Ballot Paper System.

In view of extension of date for making request for postal ballot paper, in terms of SBEC's letter No. 2024/SBEC-III/Elections dated 27.11.2024, some units have made a request for placing a ballot box exclusively for collecting voted postal ballots at Division too or else the voted postal ballots are likely to be wasted due to paucity of time.

2. The SBEC had considered the request and decided that in relaxation of relevant sections of Annexure VI of Final Modalities dated 09.09.2024 and subsequent instructions, a Ballot box (sealed in the same manner as prescribed for sealing of ballot boxes in booth) may be kept in office of Presiding Officer in the division. Postal ballot beneficiaries may drop their voted postal ballot in the ballot boxes so kept. On conclusion of voting, the Ballot box in the sealed condition should be securely delivered to Returning Officer (RO). The box shall be opened in RO's presence in HQ. RO's may issue operational guidelines for this activity and also regarding the officials to be deployed for transfer of sealed box to HQ with required security. These instructions should be widely circulated and advised to contesting unions.
