

**Sub:- Campaigning and Holding Public Meetings for SBE-III.**

**Ref. :-** Para 6.5.7, 6.5.8, 6.5.9 & 6.5.10 of Final Modalities circulated vide this office letter No. SECR/ P-HQ/ IRM/SBE-2024/PO/E-149694/1625481, dated 09.09.2024.

Your attention is being drawn to Para 6.5.7, 6.5.8, 6.5.9 & 6.5.10 of Final Modalities regarding Campaigning and Holding Public Meetings in connection with SBE-III, which are reproduced below :

**"Para 6.5.7 – Campaigning by elected representative (who do not hold any post in any of the contesting TUs or National Federation or Central Trade Union to which the contesting Union is affiliated) is not permitted."**

**"Para 6.5.8 – Campaigning within 100 meters of polling booths and holding public meetings during 48 hours prior to the start of the polling is not permitted."**

**"Para 6.5.9 – Intimidation of any type/ threatening or coercing any Railway Servants to vote/or not to vote in a particular manner is not permitted."**

**"Para 6.5.10 – Possession of firearms during canvassing, slogan shouting, inciting communal/ political/ religious passions shall not be permitted."**

Any deviation/violation of above instructions shall attract the provision related to enforcement "(Code of conduct / Discipline of Annexure-II ), to Final Modalities 2024 for SBE-III (section 6.4 of Final Modalities) & imposition of monetary fines shall be imposed accordingly.
